New member recommendations to the Board of Directors:

On February 25, 2020 I received an application for membership from Jon Sivell, at Charcoalblue LLC New York. He applied for Full Member. The application included four completed projects and two projects still in construction. When this was brought to his attention, he replied that he had interpreted one of the examples from the instructions as suggesting that projects which had completed design but not yet opened were acceptable. He updated his application quickly and the membership committee unanimously recommends Jon Sivell as a full member.

On March 4, 2020 I received a complete application for membership from Jerad Schomer, at Charcoalblue LLC New York. He applied for Full Member. The membership committee unanimously recommends Jerad Schomer as a full member.

On March 5, 2020 I received an application for membership from Clemeth L. Abercrombie, at Charcoalblue LLC Chicago. He applied for Full Member. The application included five completed projects but one of the projects was the same as listed in the Jerad Schomer application. When this was brought to his attention, he replied that they had both provided different scope on those two projects and were principally responsible for their respective scopes. He also thought that the listed projects needed to be completed in the past five years. I requested that he revise his application to contain five completed unique projects and that they did not need to be completed in the past five years. He updated his application quickly and the membership committee unanimously recommends Clemeth L. Abercrombie as a full member.

The Membership Committee suggest that sponsors make sure that prospective members are aware that:

Five completed projects (not necessarily in the last five years) are required for each application where the applicant was the "responsible person in charge". If multiple people from the same firm are applying that they are required to have five individual projects per application to avoid confusion over the "principal in charge" clause in the application.

Concept designs and feasibility studies do not comply for project submission. Duane Wilson will be updating the entire application package to make these requirements clearer shortly after the annual meeting.

FORUM 2019: Havana, Cuba October 23-27 Was a great success for those who participated. - a. Over the past year the Technical Standards Council has reviewed and approved 25 new or revised standards ranging from overhead hoist anchoring to control protocols to audience safety issues.
- b. Members of the TSC who also serve on the various ESTA working groups assist the rest of us on the council when clarification is required.

#### R. Duane Wilson:

a. The A117.1 committee had an online meeting in late February to resolve some issues left over from the last cycle. This was a first step to the beginning of a new cycle. HUD has announced the intention to accept A117.1 as a safe harbor for housing issues. While not affecting our industry, it is an indication that the standard is being accepted by the government. b. ESTA has completed a new standard on temporary followspot positions as well as a rigging inspection standard. ASTC members should download and read these standards.
