



## ASTC PR Content Article Policy

- Articles provided to the ASTC for publication are understood to be “works for hire” and subject to the terms herein.
- Article Types:
  - Specialist Articles: This policy generally is applied to articles or work product provided to the ASTC by member authors to share knowledge or expertise with the entertainment or building design industry and published via the ASTC website, social media, or other formats.
  - General Assignment articles and Press Releases regarding the ASTC’s activities. This policy is not intended for articles written by ASTC members to promote the ASTC’s activities, functions, recognitions, etc, typically by members of the PR Content committee. In the case of these article types, members are writing on behalf of the ASTC, and there is no commercial interest anticipated for the work product.

## Copyright

- All articles on the ASTC website are considered to be covered by the ASTC’s blanket copyright to protect ASTC and the associated materials.
- Where an article includes the Intellectual Property (IP) of their own or their firm, such as drawing details, photographs, or concepts, the author or their firm are licensing the ASTC to use the IP for the purposes of the article. License may be revoked for future use with written notice. If required, ASTC will include language identifying the IP as the property of the licensing organization.

## Members and their firms

- The ASTC assumes authors have permission from their firms to write; neither questions of ownership between the member/author and their firm, nor the use of company time or resources will be determined by the ASTC.

## Outside publishing by 3<sup>rd</sup> Parties

- The ASTC reserves the right to permit publishing of Specialist and General Assignment articles by Third Party publications or organizations. Such publication shall be authorized by the PR Content Chairperson.
- The PR Content Chairperson shall contact the original author of the Specialist Articles for permission and cooperation to facilitate 3<sup>rd</sup> Party publishing.
- All 3<sup>rd</sup> Party publications shall include credit to the ASTC as follows: “This article was originally published by the American Society of Theatre Consultants (ASTC) at [www.theatreconsultants.org](http://www.theatreconsultants.org).”
- No credit is expected or required for Press Releases which are intended to further the mission of the ASTC.



#### Use by Authors or an Author's firm

- The authors of articles or their employer retain ownership of their work, as determined by their contractual employment arrangement. ASTC will avoid becoming involved in employment contract matters in relation to authorship and ownership. The author assumes responsibility for acquiring any permission required by their employer.
- Authors or their firms grant the right of first publication or use to the ASTC. The ASTC may publish or republish the work as it chooses, in any format. The ASTC may revise, edit, adapt, or create derivative works from the original work in perpetuity.
- Authors or firms may republish the work for their own use ninety (90) days or more after first publication by the ASTC.
- ASTC requests member or their firms include "This article was first published by the American Society of Theatre Consultants (ASTC) at [www.theatreconsultants.org](http://www.theatreconsultants.org)."

#### Use by other ASTC members

- Members are welcome and encouraged to share articles to third parties by providing links to the ASTC web stories or by promoting via social media.
- Members who are not authors of articles may not use the article as their own work, as would be consistent with the ASTC Code of Ethics.
